II. That the Holy See, also known as the Roman Catholic Church and the Catholic Church, has its principal place of business in the Vatican City, Rome, Italy, but also has subsidiary branches in every country and in virtually every state of the world with a total of visible assets believed to be about 400 billion US dollars and hidden assets of 3000 to 6000 billion US dollars (as of 2006) as the Single largest and richest organization in the world.

III. That the Catholic Church was recognized for over 1600 years until the early 20th century as the single largest and richest organization in human history, dominating virtually every class of property, including (but not limited to) property, gold, silver, diamonds, stocks and priceless artifacts.

IV. That the Jesuits, also known as the Society of Jesus or " Societas Iesu ", have their principal place of business at the Jesuit headquarters in Vatican City, Rome, with total visible assets of approximately \$3 billion and hidden assets of between \$2,000 and \$5,000 billion (at 2006) as the second richest organization in the world after the Holy See.

V. That the Jesuits have, since 1814, effectively controlled the Asset Management of the Roman Catholic Church, as well as its own asset base and its restoration as an order. The Jesuits engage in commercial transactions through a highly complex system of trusts, shell companies and commercial banks that use confidentiality laws to hide the true wealth of the Roman Catholic Church and its subsidiaries.

VI. That the Vatican Bank, also known by its official name " Istituto per le Opere di Religione " or Institute of Religious Works ("IOR"), has its principal place of business in Vatican City, Rome, Italy, but conducts business and financial transactions throughout the world from named after the Roman Catholic Church, including Russia and with total global assets believed to be between US\$3 and US\$7 billion (as of 2006).

VII. That the Holy See, also known as the Roman Catholic Church and the Catholic Church, their Orders and Societies, as well as their successors, successors, assigns, are involved in such rituals, rites and worship, namely:

**Attis - day of blood atonement** (celebration of Attis, the day of blood when new ordains to the Cybele priesthood showed their dedication by cutting off their genitals in a bloody frenzy and celebration.)

**Blood sacrifice to the Mother Goddess Cybele** (rituals of sacrificing a man or woman for his blood, including rituals involving self-harm for blood loss, were a major area of worship for the Mother Goddess).

**Drowning Sacrifices to the Gods** (the sacrifice of people by throwing them from great heights, sometimes in bags or by ritual drowning, has its origins in a distinct deity from the mother goddess and demons. Such sacrificial methods were universally intended for the worship of Motu, the God of Death.)

**Burning people alive to Moloch** (ritual of burning people as a human sacrifice)

**Sacred dismemberment of people in honor of Osiris** (slaughter and rebirth at the same time:

- Slaughter and sacred cannibalism, ritual slaughter and dismemberment, including the consumption of certain flesh and organs representing sources of power, including the liver and heart. This variant of treating organs as special sources of power became popular under Hyksos rule.

- Slaughter and sacred cannibalism by mixing blood into bread - sacred Eucharist/Communion (thanksgiving, gratitude, gratitude)

- The sacred slaughter of innocents, and then the mixing of their blood with unleavened bread or oats, which is then consumed as the sacred Eucharist.)

**Sacred cannibalism** (there are two types of cannibalism in relation to the fertility goddesses of the ancient world - literal cannibalism, associated with frenzied death associated with Osiris, in which the flesh and blood of a human victim is eaten by the pioneers in a frenzied state called the meaning of " omophagy ". The other was "more refined " ritual of the Holy Eucharist, in which the blood of the victim was mixed with unleavened bread to form the Eucharist.)

**Cultural genocide** (Cultural genocide is the deliberate destruction of the cultural heritage of a people, nation or civilization for political, military, religious, ideological, ethnic or racial reasons.)

**Cultural Parasitism** (Cultural parasitism is the deliberate corruption, control, and sabotage of a culture by adopting a false identity as a trusted cultural leader in order to assume positions of influence to effect ultimate change.)

**Ritual mass sacrifice** (Ritual mass sacrifice is the deliberate and systematic killing of more than 100 people based on religious beliefs and ritual processes.)

**Political mass murder** (Political mass murder is the deliberate and systematic killing of more than 100 people based on their ethnicity, race, religion, culture and/or nationality.)

**Cultural sabotage** (Cultural sabotage is the deliberate destruction of culture and/or society by weakening basic functions, leading to extreme consequences such as the strengthening of fascist/dictator regimes and/or civil war/civil unrest.)

**Supreme Godly Duality** (Supreme Godly Duality is the act of supreme religious/spiritual figures openly preaching moral restraint, virtue and peace while secretly advocating war, terror, satanic worship, murder and social corruption.)

**Sexual sacrifice ritual** (sexual human sacrifice ritual is the killing of a person during some kind of ceremonial ritual that involves sexual acts before, during, or after the killing.)

**Slave trade** (enslavement is the deliberate deprivation of freedom and/or rights of persons, often involving forced detention, through the use of violence, threat of violence, intimidation, financial threats or inducements and/or other psychological methods in order to effectively control the actions of those persons. Slave trade - this is the enslavement, transportation, purchase and sale of such persons.)

**Pedophilia** (pedophilia is when a person of adult age engages in intimate sexual relations with a person under the age of 14, regardless of whether such relations involve penetration, but overt acts of a sexually provocative nature. It does not matter whether the statement is that such contact is “voluntary” when it comes to such actions, this does not apply to two adults.)

**Murder** (Homicide causes the death of another person without lawful justification with the intent to kill or with the intent to cause grievous bodily harm.)

**Sexual assault** (Sexual assault is when a victim is forced to engage in sexual activity, particularly sexual penetration, against his or her conscious consent through the use of physical force, threat of injury, or other coercion.)

**Economic rationalism** (economic rationalism is the prevailing philosophy of most global corporations and governments, which holds that business activities and decisions, while they affect society, are bound by the laws of economic self-interest; therefore rational (accounting) values rather than moral values should take precedence)

1. The founders of the above organizations and their successors, successors, heirs, were Paul of Tarsus, Joseph Ben Matthew and the Jewish Sadducee high priests from the house of Ananus, and not Jesus and the apostles;

- The purpose of creating a joint Foundation has always been the sole purpose of an organized criminal enterprise, including, but not limited to: subversion, fraud, murder, extortion, kidnapping, terrorism and undermining public morals by:
  - (a) Render the Gnostic teachings of Jesus and the Nazarenes ineffective by creating a counter-religion claiming to be the one true faith that focuses on simplistic symbolism, conformism and hatred of knowledge.

2. List of crimes that affected, caused moral and material damage to the Estate and the Dorozkin/Vorobiev Family, the above organizations and their successors, legal successors, heirs:

- **In Crimes Against Humanity** (1814-1815 AD): The Congress of Vienna, at which members of the remaining powers of Europe were to decide on the redrawing of borders and conditions after Napoleon's imprisonment, was sponsored, planned and influenced by the Jesuits the Jesuits, offering significant financial incentives including: rewarding Russia

for supporting the Jesuits, the return of the papal states promised to the Pope, punishment of Spain, and a general suppression of liberalism and human rights reform in favor of the restoration of feudal-monarchical and autocratic rule.

- **In political assassinations** (1825 AD): The Jesuit Superior General Luigi Fortis ordered the assassination of Tsar Alexander I of Russia in 1825, for the expulsion of the Jesuit order in 1820 and the confiscation of their property in Russia.
- **In the creation of an illegal enterprise for the purpose of committing a crime** (1907-1990 AD): The Jesuit Superior General Franz Xaver Werntz organized the financing and creation of the Communist Party and regime in Russia. That the Jesuit priest Joseph Stalin was recruited to represent the interests of the Catholic Church. That the original goal of the Communist Party was to suppress democratic ideals, create a centralized society, eliminate the Russian Orthodox Church and noble families, and promote the Catholic Church.
- **In creating the conditions for violence and confrontation** (1904-1914 AD): The Catholic Church, through its agents and the Jesuits, provided funds through attractive loans through its banks in Russia, Germany and France for the production of weapons by companies that it also nominally controlled. This aggressive arms build-up forced the UK to also invest in developing its own weapons, thereby creating a European arms race. At the same time, the Jesuits encouraged, supported and directed the development of clear strategic plans for each major country, including the German Schlieffen Plan (1905), which called for a simultaneous attack on France and Russia, the French Plan XV (1903), which called for a purely defensive approach to the German border, and France, and the Russian Plan XIX, which involves the fight against Austria-Hungary and Germany.

### **Bank for International Settlements (BIS)**

The private banking cartel, based in Switzerland, was first formed in 1933, between the Vatican Bank, by the private US Federal Reserve Banks, the Bank of England and the Nazi banks to redirect huge amounts of gold, as the standard underwriting asset of world currencies, back to the central banks, subject to policy conditions and increased debt obligations.

It remains the most secretive division of the debt-based Industrial Banking Cartel and has constrained and controlled global finance for over eighty years. The influence of the BIS has declined steadily over the past two decades as more central banks have rejected the BIS's continued commitment to restraining real wage growth and wealth growth in non-industrialized countries. However, the influence of the BIS returned to predominance after the deliberate collapse of debt-based monetary systems, which forced many central banks to reenter agreements with the BIS.

### **International Monetary Fund (IMF)**

The financial institution that forms the basis of the IMF was originally conceived in July 1944 by the United States and 43 allies at the Mount Washington Hotel, Bretton Woods, New Hampshire - hence the name "Bretton Woods Agreement". The IMF was officially created in December 1945, and only 29 countries initially signed its Articles of Agreement. Its main innovations were the adoption of a common exchange rate mechanism based on a basket of currencies dominated by the US dollar, and a financing mechanism based on the underwriting of debt rather than the underwriting of historical assets such as gold or other commodities. After several spectacular failures and system failures, the IMF introduced the SDR (Special Drawing Rights) as a de facto unit of currency, backed by a modest supply of gold.

### **Federal Reserve System (US Federal Reserve Banks)**

An inferior cartel of private banks. Formed in 1913 when the US government transferred control of its currency to this private banking group, nominally owned by US banks but ultimately owned by private banking interests, mainly in Europe, especially Rome and Zurich. The Federal Reserve Banks are a key element of the debt-based Industrial Banking Cartel, but are unique in that they are so open to the successful redistribution of Americans' public wealth to private banking families and church groups. The Fed is also unique in that it has never achieved its core social goals, and is both the primary cause of the unprecedented level of US debt and the institution that manages the debt. The Fed remains untouchable

## Global financial system

The set of partly public and regulated, unregulated and largely hidden networks of debt and asset control that constituted the historical "system" of financial management up until 2009. Deliberately and erroneously described as a "system", it is best described as consisting of five separate and often competing/conflicting networks:

- 1) Industrialized debt-based banking cartel, represented by the IMF, US Federal Reserves, Bank of International Settlements and the World Bank;
- 2) Wholesale money and bond markets, dominated by institutions such as the London Interbank Offered Rate (LIBOR);
- 3) Unregulated hedging and speculative debt markets;
- 4) Private ownership of huge amounts of gold, silver and assets
- 5) Central and regional banks of the world. On the contrary, the Supreme Financial System eliminates the ability of private cartels to manipulate scarcity of capital, demonstrating a seamlessly integrated and completely public financial model.

## Industrialized banking cartel based on borrowing

A term used to describe the various bodies formed after the Second World War, designed to essentially "secure" the permanent dominant financial position of the banking networks of industrialized countries, mainly Europe and North America, contrary to their "public" stated goals. These include the IMF, the Bank for International Settlements, the private US Federal Reserve Banks and the World Bank.

## The World Bank

Trademark of two junior banks with nominal shareholdings from 184 countries, but controlling stakes in a few: the International Bank for Reconstruction and Development (IBRD) and the International Development Association (IDA). The World Bank was one of the key instruments of the debt-based Industrial Banking Cartel to maintain control of global wealth.

- **Inciting violence and political revolution** (1917-1918 AD): The Catholic Church, under the control of the Jesuits, financed, organized and carried out the political coup that led to the February Revolution in Russia and the overthrow of Tsar Nicholas II. The Catholic Church even arranged for Vladimir Lenin and other exiled Swiss revolutionaries to travel safely across the First World War front lines by train under the official colors of the Pope and the Vatican. That the motive for Lenin's return to head the new government was Stalin's inability to gain sufficient control over the factions among the revolutionaries at the time.
- **In Crimes Against Humanity** (1917-1918 AD): The Catholic Church, through the Jesuit Order, incited violence and unrest in Russian communities, resulting in the murder of more than 60,000 Jews in 530 Russian communities after a political-religious uprising broke out, the purpose of which was "to strike at the bourgeoisie and the Jews."
- **In political assassination** (1924): That the Jesuit Superior General Vladimir Ledochovsky ordered Joseph Stalin to kill the leader of Communist Russia on January 21, 1924 at the age of 53. That Stalin acted to protect his position and mission as General Secretary of the Communist Party after Lenin insisted on his removal. That Stalin not only poisoned Lenin, but after coming to absolute power, he spread rumors that Lenin was mentally ill in the last years of his reign and even died of syphilis.
- **In the creation of an illegal enterprise for the purpose of committing a crime** (1920 - 1945 AD): Archbishop Pacelli, later Pope Pius XII, and the Jesuit order under Superior General Vladimir Ledochovsky helped create the German Workers' Party (abbreviated

DAP) in the National the Socialist German Workers' Party (NSDAP), also known as the Nazi Party at the behest of Adolf Hitler. The original purpose of the Nazi Party, formed by the Catholic Church, was: (1) to create a pro-Catholic political party capable of defeating its opposition and gaining control of the government; (2) the conclusion of a concordat between the Catholic Church and all of Germany, guaranteeing huge financial revenues as compensation for the loss of papal lands; (3) the destruction of all opposition, including social reform/democracy groups, especially Protestants, Orthodox Christians, communists and ethnic Jews. Archbishop Pacelli (later Pope Pius XII) mentored Hitler to join the DAP, arranged for him to report regularly to him (at least every month, sometimes weekly) until Pacelli's appointment as Vatican Cardinal Secretary of State in 1929, and provided all financial support and funds for for Hitler to become chairman of the NSDAP on July 28, 1921. Moreover, Archbishop Pacelli used gold imported into Germany in 1917 to finance the rapid expansion of the Nazi Party, including its first reform as a paramilitary organization in 1921.

- **In the creation of an illegal enterprise for the purpose of committing a crime (1921 - 1945 AD):** Archbishop Pacelli, later Pope Pius XII, on the instructions of Superior General Vladimir Ledochowski in 1921, instructed Adolf Hitler to create a paramilitary wing of the NSDAP called the Stormtroopers squads (SS), also known as Stormtroopers. That the Jesuit priests actually trained the first SS recruits in espionage, counterintelligence, assassination and propaganda. The purpose of the SS was to assist in the control of organized protests, riots, intimidation of opponents and political assassinations.
- **In creating an illegal enterprise for the purpose of committing a crime (1929 - 1945 AD):** Superior General Vladimir Ledochovsky, through his Jesuit emissaries, instructed Adolf Hitler in 1929 to reform part of the Sturm unit (SA), also known as "Stormtroopers", in Schutzstaffel, also known as "SS". Unlike the SA, which was staffed by a variety of qualified men, the Jesuits instructed Hitler that the SS was to be the most secret organization of personal bodyguards and elites, staffed and controlled by actual Jesuit priests. SS officers would be endowed with the authority of the Jesuits and the authority of the Pope with the authority of the Catholic priesthood. In addition, SS priests were to be integrated into the organization to ensure strict control and prevent schism. In exchange for this, the Jesuits agreed to personally finance the implementation of the project, as well as to bring their significant funds and industrial interests to Germany; on January 6, 1929, Adolf Hitler appointed Heinrich Himmler to lead the project.
- **In the receipt and trading of proceeds of crime (1933 - 1945 AD):** The Catholic Church, with the authority, knowledge and control of Pope Pius XII, conspired and received more than US\$10 billion (2006 equivalent) in payments from the National Socialist Workers' Party of Germany, also known as the Nazis, in exchange for moral and logistical support for the Nazis' policies of ethnic cleansing and genocide.
- **In the greatest crime against humanity in the history of all mankind (1939-1945 AD):** Pope Pius XII, with the full knowledge and tacit support of the Jesuit General Superintendent Vladimir Ledochowski, conveyed to Hitler and Himmler a complete plan for the systematic extermination of major non-Catholic minorities throughout Europe, as well as the creation of death camps to kill them. Moreover, the Pope ordered that ethnic Jews and other heretics not only be killed, but ritually sacrificed by being burned alive, in accordance with the Church's law on the punishment of heresy. This plan was to begin immediately and be carried out under the supervision of Jesuit SS priests. This plan was called the "Final Solution." As a result of specific orders from Pope Pius XII, the German command developed an ingenious method that made it possible to bring Jews and other heretics out of unconsciousness within a few minutes through gas chambers using the drug

Zyklon - B , produced by the Catholic pharmaceutical company Bayer . The unconscious victims were then placed on stretchers and taken to massive ovens where they were placed fully alive, only to wake up screaming as they were burned alive in the oven. Contrary to the military deception perpetrated by the Allied commanders loyal to the Vatican, the death camps were established as early as 1940, at least two full years before what was announced at Nuremberg. Moreover, the camps only stopped immolating people by burning them alive in 1945. That the sole purpose of the ovens in the death camps was not to destroy bodies, but to specifically burn people alive, in accordance with the ancient satanic practice on the basis of which Christianity was first formed by the Jewish noble families of the Sadducees. This plan, created by the Vatican, sanctioned by Pope Pius XII and carried out by full Roman Catholic priests who controlled the concentration camps and furnaces, represents the greatest and most evil act in human history to date. Moreover, the deliberate misrepresentation of the facts, the fact that the Pope was never tried as one of history's worst mass murderers, only deepens the contempt for international justice and the memory of all those killed.

- **In one of the greatest crimes against humanity** (1939-1945 AD): The Catholic Church through its deliberate placement of key figures, including loyal Catholics Mussolini, Hitler, Franco and Stalin, and through its financing of the second European arms race, including deliberate prolongation of the war, was directly and ultimately responsible for the deaths of more than 63,000,000 people between 1939-1945. - The Absolute Right of Time for Defence, also known as ( Ius Defensionis Tempus), inherited from ( Ius Naturale Aequum ).
- Absolute Right of Consideration, also known as ( Ius Oratorium ), inherited from ( Ius Naturale Aequum )
- Absolute Right of Autonomy, also known as ( Ius SuiIuris ), inherited from ( Ius Naturale Aequum ).
- Absolute Right to Representative, also known as ( Ius Agens), inherited from ( Ius Naturale Aequum ).
- The absolute Right to a fair decision, also known as ( Ius Iudicium ), inherited ( Ius Naturale Aequum ).
- The Absolute Right of Jurisdiction, also known as ( Ius Tribunal), inherited from ( Ius Naturale Aequum ).
- The Absolute Right to a Good Conscience, also known as ( Ius Bonum Fidei), inherited from ( Ius Naturale Verum).
- The Absolute Right of objectivity and without prejudice, also known as ( Ius Sine Praejudidum ), inherited from ( Ius Naturale Honestas ).
- The Absolute Right to Clean Hands, also known as ( Ius Mundis Manibus ), inherited from ( Ius Naturale Honestas ).
- The Absolute Right of Validity, also known as ( Ius Habeas Corpus), inherited from the Natural Right to Challenge Detention without Evidence and Legal Basis, also known as ( Ius Naturale Honestas )
- The Absolute Right of Command, also known as ( Ius Mandamus ) , inherited from the Natural Right to require an officer to perform his professional duties, also known as ( Ius Naturale Honestas )
- The Absolute Right of Evidence, also known as ( Ius Quo Warranto), inherited from the Natural Right to require proof for any claimed existence of authority and authority, also known as ( Ius Naturale Honestas )
- Absolute Right of Claim, also known as ( Ius Certiorari), inherited from the Natural Right to have the case transferred to the competent authority, also known as ( Ius Naturale Aequum )
- Absolute Right of Prohibition, also known as ( Ius Prohibitio ), inherited from the Natural

- Right to demand the termination of legal actions, before a decision is made by the competent authority, also known as ( Ius Naturale Aequum )
- Absolute Right of Production, also known as (Ius Procedendo), inherited from the Natural Right to require that an action be commenced subject to the existence of a proper judicial decision, also known as ( Ius Naturale Aequum )
  - The Absolute Right to Correct Error, also known as ( Ius Error Coram Nobis), inherited from the Natural the right to require that certain errors in a record be corrected, also known as ( Ius Naturale Aequum )
  - The Absolute Right of Revocation, also known as ( Ius Scire Facias), inherited from the Natural Right to require that false claims be withdrawn or returned to the claimant, known also as ( Ius Naturale Aequum )
  - Absolute Power of Dissolution, also known as ( Ius Jus Sentio ), inherited from the Natural Right to dissolve a mandate or revoke a warrant for the purpose of an election, known also as ( Ius Naturale Aequum )
  - Absolute Right to land, also known as ( Ius Terram ), inherited from ( Ius Naturale Terram ).
  - Absolute Right to Use of Land, also known as ( Ius Usum Terram ) inherited from ( Ius Naturale Usum Terram ).
  - The absolute right to change the boundaries of the territory, also known as ( Ius Mutat Terram ), inherited from ( Ius Naturale Mutat Terram ).
  - Absolute Mining Right, also known as ( Ius Fodere Terrain), inherited from ( Ius Naturale Fodere Terram ).
  - Absolute Right to Water, also known as ( Ius Aqua), inherited from ( Ius Naturale Aqua).
  - The Absolute Right of Racial Equality, also known as ( Ius Aequum Gens ), inherited from ( Ius Naturale Aequum Gens ).
- Second Article (2) – Status of Law.

The status of any valid right expressed or affirmed in this Sacred Act is its relative status or condition, position, force, priority and position, as compared with one or more other rights, according to the following facts:

- Only valid rights can have their own status, since a valid right always trumps an invalid, false or prohibited right.
- An actual right received from another will always be inferior to the actual right from which it comes.
- Divine Right is superior to Natural Law, and Natural Law is superior to Positive Law
- Perfect Divine Right is superior to imperfect Divine Right.
- Absolute Natural Law is superior to Relative Natural Law.
- Natural Positive Law is superior to conventional Positive Law.
- A valid right of the same subclass and type, relating to the same person, may be equal or indeterminate and may therefore be subject to proper investigation by a competent judicial authority.

Article Three (3) – Transfer of Rights.

The transfer of any rights, titles and property associated with this sacred document is made in accordance with the following basic four elements - writing, authority, seal and recording:

- Writing means that all valid transfers of any rights, titles and property are in accordance with this sacred document must always be in writing.
- Authority means that all valid transfers of any right, title or property in writing shall always be made by a duly authorized fiduciary or agent in accordance with this sacred instrument.
- Seal means that all valid written instruments of transfer of property by duly authorized trustees or agents must always be duly affixed with one or more official seals of the superior class.
- Recording means that all valid transfers of any right, title and property shall be duly recorded

in the rolls and registers of the superior class in accordance with this sacred document.

- Any assignment which fails to provide evidence of the above-mentioned four essential elements of writing, authority, seal and recording is hereby void and of no force or effect.
- Any party not named herein who has evidence of a valid claim for conveyance on a particular day and time, subject to this Sacred Instrument, may duly assert a valid claim.

Article four (4) – Assertion of law.

The valid assertion of any right is always made under the rule of law, through justice in accordance with the present seven forms of action: record, notice, stipulation, order, demand, promissory note and petition:

- A record is a written record of a valid right, preserved in writing as evidence, usually within a specific book of records known as a register. A title corresponding to an entry in a register may indicate any legal title, while the presentation of any receipt or certificate from such a register may indicate the existence of an objective title.
- Notice is the assertion of one or more valid rights through a legal process in which a party is informed of any formal legal matter that may affect certain rights, as well as of the form of document used to convey such facts. The main types of notice are public (legal), factual, constructive and implied.
- A reservation is an assertion of one or more valid rights by notice in which the documents conveyed expressly state in writing the confirmation of certain rights. Thus, the presence of such an express statement regarding the assertion of certain rights does not permit the recipient of such documents to assert rights to infringe, seize, suspend, disqualify, contract, seize, alienate, forfeit or extinguish any of the asserted rights, including, but not limited to , any rights expressed or implied in the contents of this document.
- A writ is an assertion of one or more valid rights by issuing a formal document of demand and authorizing one or more agents to direct certain actions to be performed, giving the agents (agent) limited protection from liability for any damages or upon filing of any - or a complaint (claim).
- A claim (complaint) is an assertion of one or more valid rights by challenging in a competent court against another party the right to the possession or use of any property or thing retained from the property of the plaintiff.
- A promissory note is the assertion of one or more valid rights by means of a special instrument and order (promissory note) whereby legal title to one or more valid rights is conveyed to a duly constituted political body by one or more persons in exchange for the proper administration and administration of such rights.
- Petition is an assertion of one or more valid rights by means of petition and petition to the highest sovereign authority in society, which demands recognition of the rule of law and justice to restore possession or ownership of any property or thing withheld from the petitioner's property by an officer or an agent of the same sovereign body (such as a government).

Article five (6) – Clause of law.

In accordance with this sacred document, the three formal types of Reservations regarding one or more valid rights of this sacred document are universal, absolute and perfect:

- The universal reservation regarding one or more valid rights of this Sacred Document means the expression “All Rights Reserved”, used in conjunction with the assignment of any copyright or instrument.
- An absolute reservation regarding one or more valid rights of this Sacred Instrument means the expression "All rights are reserved in trust for the Goddess." It must be used when transferring any copyrighted items or tools. This phrase clarifies that “All rights belong to the True Divine Creator,” using language in accordance with the principles of all Western Roman law. Therefore, the violation of such rights implies not only a violation of sacred trust, but also a failure of the rule of law.

- A perfect reservation to one or more rights of this Sacred Instrument is when the phrase "All rights are reserved in the Sacred Trust hereunder under the True Divine Creator and Creator." It must be used in conjunction with the transfer of any materials or shipments. The phrase makes it abundantly clear that all rights are held in sacred trust under the authority of the Goddess True Creator and Creator in accordance with the highest legal form. Therefore, the violation of such rights implies not only a violation of sacred trust, but also the abandonment of all possible forms of the rule of law and justice.

Article Six (6) – Claim of Right.

Subject to this sacred act and the assertion of one or more valid rights through challenge before a competent court, in relation to the possession or enjoyment of any property or thing retained from the property of the plaintiff, the claim of right is found to be valid and motivated on the basis of the following essential criteria, identification, certifications, considerations and obligations:

- Identification of a claim means that the claimant clearly identifies himself, his status and capacity in connection with the asserted claim.
- Certification of title means that the plaintiff presents a certified and true copy of a document issued by a duly authorized attorney or agent under the official seal and signed and executed to confer upon the duly identified plaintiff one or more rights giving rise to the claim.
- Review of the Agreement means that the claimant submits complete copies of eligible agreements, signed by a duly authorized attorney or agent under the official seal, for each separate reporting period at issue in connection with this claim and demonstrates the good faith execution carried out by the claimant, the terms and conditions and obligations under the agreement, the agreed fee schedule and any penalties for any violation of the agreement.
- An undertaking to pay compensation means that the applicant submits certified and true statements of any regular payments, or performance or services provided to the applicant, and evidence showing one or more violations in respect of duly signed and sealed agreements in respect of which an obligation for compensation may be imposed.

Article seven (7) – Legal dispute.

A legal dispute is when a party who recognizes and respects the due rule of law, fairness and due process of law disagrees as to the operation of one or more of the legal provisions of this Sacred Document. According to this sacred document, the main concepts used to resolve such a dispute are the following, validity, obligation, status and priority:

- Validity is the determination of whether the rights in question are valid in accordance with this covenant. There is no such thing as a false or invalid right. An indefinite right in relation to an actual right is by definition inferior.
- Duty is the determination whether a right remains valid because of the necessity of fulfilling some obligations and duties, as in the particular case of all imperfect Divine rights, relative natural rights and conditional positive rights. Evidence of failure to perform a duty may invalidate a right even if it is superior in status.
- Status is the determination of whether one valid right is superior or inferior to another by virtue of belonging to a higher class or subclass, provided there is no evidence of non-fulfillment of any prescribed obligations or duties. Barring such evidence, there are no higher valid rights than divine rights, followed by natural rights, and then positive rights.
- Priority is the determination of whether one valid right of equal importance in terms of superiority has greater value by virtue of a prior record, notice, order or demand, thereby identifying such valid right as a valid prior right against any other claim. .

Article Eight (8) – Invalid and prohibited rights.

A void right or false right is any form that claims to be a valid right but is contrary to or violates the golden rule and the proper rule of law, due process and fairness, and one or more

of the criteria relating to the rights defined in this Sacred Document.

A forbidden right is a false right and an invalid right which proclaims one or more of the following self-evident false tenets and is therefore automatically void, having no force or effect ecclesiastically , legally or legally:

- any right that cannot prove its true origin is opposed to actual Divine right.
- any right that proclaims immunity from the operation of the law from which this right follows.
- any right which declares immunity from duties or obligations implied by such right.
- any right that declares that a man or a woman can be defined or treated as a thing.
- any right which declares that, by virtue of being born of flesh or blood, one man or woman is superior to another.
- any right that proclaims the right to create secret laws or rights unknown to the public.
- any right that proclaims the exclusive right of one group, body, collective, association, person, political body to apply any law to the detriment of society as a whole.
- any right which declares that a man or woman may be considered guilty or liable before the charge has been proven.
- any law which declares that an officer or agent holding such office or position in the Trust may ecclesiastically , lawfully and legally give intentionally false statements or false and misleading information.
- any right that proclaims the ability to suspend the rule of law, due process and justice to gain an advantage for or against someone.
- any law which makes it possible for a man or woman to hold the office of judge or magistrate and to act in that capacity without due oath.
- any law which makes it possible for a man or woman pretending to be a judge or magistrate to consider and decide questions of law unjustly, in bad faith or with prejudice.
- any law that proclaims the right to treat a financial or legal advantage obtained by fraud as legal and legitimate.
- deny the existence or validity of this Sacred Document and therefore seek to render part or all of its parts void, illegal or unlawful.
- any right of a foreign power which asserts a superior right to power or jurisdiction over this Sacred Document.
- Any right of a foreign power which claims, but denies, the recognition of the rule of law, due process and justice and asserts the right to own, occupy, enjoy and dispose of property arising from the rights defined by this sacred act, shall be subject to it.
- withdrawn, a position forcibly abandoned, a person dismissed, disqualified, arrested, property alienated, confiscated or liquidated, without due respect for the rule of law, due process and justice.

Article Nine (9) – Creation and name.

1. By the power and authority of our Absolute right to the name, I hereby proclaim from the very beginning forever and ever (Initially and justified, here and further from the very beginning forever and ever) that my only supreme Estate is the Estate known as Maria Mikhailovna , Maria Vorobyova, also known as the Estate of Maria Mikhailovna Vorobyova, Maria Vorobyova, as well as all their abbreviations derived from it, regardless of the language of writing or printing, mmv , vmm , mmv, mv , etc. inherited from the Right to a Name ( Ius Nomenis )
2. Whenever one or more of these names is used, whether such names are in the Higher Register, the Lower Register or the Proper Register (Internal Documentation), it will mean only my Estate and no other.
3. In accordance with the Absolute right of ownership of property and with the right to dispose, manage, this property, I have, own, use and dispose of the name and all its derivatives. Moreover, by force and authority, I do hereby grant, grant and convey all rights and title of name to my one and only Estate from the beginning forever and ever, inherited

from ( Ius Possessionis ), and ( Ius Habendi ) and ( Ius Proprietatis ) and ( Ius Concedere )

4. Whereas my name is ultimately derived from our Sacred and Divine right, and any certificates, notes, stocks, securities, bonds, annuities, insurances, deposits, mortgage transactions, promises or derivatives remain the right, property, possessions of our Estate from the very beginning forever and ever, including those unknown at the moment and hidden from me, unless a written permission, warrant or deed is issued for them, sealed in confirmation of someone else's proper rights and powers, in accordance with this sacred instrument, inherited from ( Ius Nomenis ) and ( Ius Divinum Nomenis )

5. I hereby reserve all rights associated with my name, and that no other party, body, organization, property, Trust, corporation, no person, officer, agent or thing may lawfully claim the right to use any derivative of the name, except for the limited non-commercial use of copyright, unless written permission, warrant or deed issued under seal and proper authority in accordance with this sacred document , inherited from ( Ius nomenis )

6. Because I prohibit the grant, grant or transfer of any superior right in my Name, other than a franchise lease, to any party, body, organization, estate, Trust, corporation, person, officer, agent or thing that claims any false right or false possession of my Name shall immediately revoke any previous authorization or agreement associated with my Name, and the General Executor and duly appointed Fiduciaries and Agents are authorized to seek immediate relief and damages inherited from ( Ius Nomenis )

Article ten (10) – Location, location and time.

1. By the power and authority of our birth, I hereby acknowledge the creation of the Record of the Living Birth and its publication in the Bulletin on the Site, which is the official newspaper: **Universal Calendar: 1 L8 4661, Constellation: Sagittarius, Day of the Week: Saturn , Time: 15 h 44 min**, which corresponds to the Roman model of society and time [20-44, August 10, 1957], confirming the creation of the True Trust Number **S-MP-Z-NS144-3-13-01135004864** and the One True Supreme Estate and that none of the declared document, authorization, certificate, edict, indulgence, declaration, record, ledger or event will not be primary, superior, more valid and superior to the above mentioned record and publication of the Record of a Living Birth inherited from ( Ius Nascendi ) 2. I, recognize the only valid time and space pertaining to the birth of our Trust and superior estates, through my Absolute right of birth, which occurred in space-time within three thousand two hundred and forty (3240) years from the beginning of the Age of the Great Aries, inherited from ( Ius Nascendi ) 3. I , I admit that the only valid event within the limits of time and space, **Ecumenical calendar: 1 L8 4661, Constellation: Sagittarius, Day of the week: Saturn , Time: 15 hours 44 minutes**, which corresponds to the Roman model of society and time [20- 44, August 10, 1957] relating to the birth of our Trust and Supreme Estate through my Absolute Birthright inherited from the Ius Nascendi (Birthright), occurred within: the Universe of Light, the Perseus-Pegasus Galactic Filament, the Pisces-Cetus Supercluster Complex, Laniakea, the Virgo supercluster, the Local Group of galaxies, the Milky Way galaxy, the Orion Arm, the Solar System, the planet Mother Earth, naturally free-born from the soil of Mother Earth, on the land of Russia, on the land of the city of Moscow, and that any other statement about the predominant right, primary right or superior right to our True Trust and our One Supreme Estate, is automatically of no force or effect. 4. In accordance with my Absolute right of ownership also known as ( Ius Possessionis ) and with the Absolute right to dispose, manage also known as ( Ius Habendi ) and with the Absolute right to property also known as ( Ius Proprietatis ) I have, I keep, possess and possess the true event and birth record and any derivatives thereof. Moreover, through the power and authority of our Absolute Right to Grant, also known as ( Ius Concedere

), I do hereby grant, grant and convey all right and title to the true event and record of a living birth and all derivative records of birth to our one supreme estate from the beginning forever and ever.

## Article Eleven (11) - ACTIONS, EFFORT AND ENERGY

1. By the power and authority of our Absolute right to consent, I have the universal, Natural and Divine Right to choose and agree without coercion and therefore agree and accept that in such conditions I am completely responsible for my actions. Moreover, in accordance with my Absolute Right to Liberty, I am free from any legal claim to slavery or power over my actions and that in accordance with my Absolute Right to Work, I am free, through my actions, to perform work, exert effort and generate energy , inherited from ( Ius Consensum ) and ( Ius Libertatis ) and ( Ius Perfungor )
2. Thus, all energy, motion, force and power created by my right to do work, exercise effort, motion and energy are entirely the property and right of our estate under my Absolute right to the fruits, and no party, body, organization, estate, Trust, corporation, person, officer, agent or thing can claim any part of such energy, motion, force and power except through the written permission of the Executor General and Guardian, inherited from ( Ius Fructibus )

## Article Twelve (12) – Great Scrolls (Lists and books of the family, estates)

By the power and authority of our Absolute right of record, a unique and original set of scrolls, books, memoranda, registers and ledgers shall be contained in stitch-bound special books or electronic media, the totality of which is called the Great Rolls, to maintain and preserve certain key records including, but not limited to the grant, use and administration of rights and estates, settlement of disputes, records of receipts and transfers of documents, and business and financial transactions of our superior estate inherited from ( Ius Registrum )

The Executor General and the Guardian are vested with the power to appoint, direct and terminate commissions under the oath of allegiance and oath of one or more authorized persons as trustees to assist in the maintenance of the rolls of our estate.

Great paper scrolls should begin with a title page followed by a verso ( abverse ) containing the opening seal and a prayer dedicated to the Divine Creator and Creator in whose name the estate will be duly administered, each page numbered in red ink at the top right corner of the page to the reverse, being the last page with the closing seal and prayer to the Divine Creator and Creator.

Within the numbered pages between obverse and reverse, the Great Scrolls shall consist of nine (9) elements, for which, if more pages are required, additional bound books will be included, as appendices with pages numbered so that neither of the two pages in all the Great Scrolls did not have the same number.

The first section in the Great Scrolls will be called Genesis (Family Book), in which my genealogy, descended from the first man and the first woman, is presented to the present time, demonstrating the unbroken line of inheritance of the Absolute right to inherit rights, also known ( Ius Hereditatis ) with details description of origin indicated by a dotted line. Thus, I assert my Absolute right not to be a thing, and not to be considered as a thing. Moreover, I assert my Absolute right to freedom, from slavery and oppression, and therefore reject all accusations and claims of infancy, guardianship, servitude, poverty or insanity inherited from ( Ius Non Res) and ( Ius Naturale Non Res) and ( Ius Divinum Non Res) and ( Ius Libertatis ) and ( Ius Naturale Libertatis )

The second section in the Great Rolls shall be called the register of births, deaths and unions, in which all the records of the births, deaths, relations and unions of the persons and ancestors of the estate shall be duly recorded and recorded by the authority and power of the Absolute Right of Record inherited from ( Ius Album) and ( Ius Naturale Album )

The third section of the Great Rolls is called the register of rights and titles, in which all records of valid rights, titles, claims and petitions for inheritance shall be duly recorded and

registered by the power and force of the Absolute Right of Record inherited from ( Ius Album) and ( Ius Naturale Album )

The fourth section of the Great Rolls will be called an inventory, which is an audit, made annually on the anniversary of the creation of our supreme estate, of all rights, titles and properties, all claims, charges, debts and obligations, and all promises, loans, grants, deposits and the gifts relating to my supreme estate are given in one complete account.

The fifth section of the Great Rolls will be called the Fund, which is an individual record created each year upon completion of the audit, whereby the pledge of the estimated inventory value and energy of my Absolute right to the fruits of the estate is determined as the amount of true coin (money) as issued in trust management of capital for the year under review. A fund is then provided for the management of the affairs of the estate and the estimated capital required to satisfy any claims and provide any capital due to the superior estate for the relevant year, inherited from ( Ius Fructibus )

The sixth section of the Great Rolls is called the register of accounts, which is a summary list of all the accounts for holding issued capital, receiving paid-up capital, and paying capital due for each fund held in trust every year throughout the existence of the estate from the beginning forever and ever.

The seventh section of the Great Rolls is called the Memorandum and is a detailed record of all the transactions that take place from day to day in respect of claims and grants, debts and credits for the existing and corresponding fund.

The eighth section of the Great Rolls is called the Judicial Rolls of Claims, Controversies, Judgments and Orders and records all disputes brought against the estate and its members

The ninth section of the Great Rolls will be called the register of orders, gifts, commissions and consents and will be a record of all promises, oaths, gifts or orders issued for and on behalf of the estate.

By the power and authority of our Absolute Recording Authority, the Executor General and Guardian shall ensure that all original legal documents, records, agreements and manuscripts relating to the registrations and records in the Great Rolls are securely kept in the office of the upper class inherited from ( Ius Album )

#### Article Thirteen (13) – Currency and systems

I hereby acknowledge and accept gold, silver, platinum coins, as well as independent digital currencies.

#### Article fourteen (14) – Coat of arms.

By the power and authority of our Absolute Right to Create, a coat of arms was created and forged, reflecting the cultural heritage of our estate, its values and motto, from the beginning forever and ever.

The General Executor and the guardian ensure the safety of the coat of arms, which can only be used by order of the General Executor, except for those circumstances that are listed as special in these articles.

#### Article fifteen (15) – Great Seal and Lesser Seals.

By the power and authority of our Absolute Right to Create, the Great Seal was created, which will be known as the Great Seal of the estate of Sergei Vorobyov, inherited from ( Ius Fecerim )

The General Executor and Guardian ensures the safety of the Great Seal, which can only be used at his discretion, except in circumstances listed in these articles as special.

Article sixteen (16) – General Executor and Guardian.

By the power and authority of our Absolute Right to Will and Covenant, I do hereby grant, bestow, invent, convey, vest and entrust all my powers and authority by this sacred document and Magna Carta to the office of General Executor and Guardian as Sovereign over all my known and unknown estates. I hereby revoke all prior powers, powers of attorney, powers of guardianship, agency or personal representation, express or implied, implied or knowingly granted by signature, name, fair use or any other lawful means. In addition, I hereby execute and terminate all previous trusts, oaths and obligations of the former guardians in connection with the exercise of all previous powers, powers of attorney, powers of guardianship, agency or personal representation, express or implied, implied or knowingly granted by signature, name, fair use or by any other legal means. Therefore no one shall be permitted to occupy, take away, or claim any office, agency, power, work or authority over any part of the superior estate, except by the express written order of the executor general and guardian, inherited from ( Ius Testamentum )

Private title of the General The executor and guardian, also known as the executor general, in all communities, shall be the trustee in all the affairs of our estate and the trustee in all the affairs of the communities as a whole.

The ecclesiastical title of Executor and Guardian General is sovereign in all matters relating to original rights.

The Oath of Allegiance must be sworn by the executor-general and guardian, as well as by all persons appointed in any temporary or official capacity:

“I (name) do solemnly swear before the one true Divine Creator and Creator of all things, before all men and women, both living and and the dead, before all forms of life, before all entities, both from this world and from other endless worlds, both from this planet and from other countless planets, before all endless universes and galaxies, before all endless spiritual dimensions, before everything light, before everything high and low, before all heaven and earth, that in the presence of witnesses, that I will truly faithfully and conscientiously, with clean hands and without prejudice, fairly and honestly serve the estate of Maria Mikhailovna from the Sparrow family and his heirs, descendants, successors, allies and people according to his laws in office (name of office), and that I will protect and preserve the Kingdom and that I will protect and preserve the rule of law and justice of the Kingdom and that I will protect and preserve all the people and persons of the Kingdom. May the light of life and love be with me.

The appointment of a general executor and guardian is effected by Magna Carta under the Great Seal of our estate, subject to.

the nominated candidate is named in this sacred instrument, or, if the actual successor is not duly named, that they are appointed and elected by unanimous approval of the trustee and testator, or, if either of them is deceased, the permanently appointed fiduciaries under this sacred instrument.

- that the nominated candidate actually made a speech and took the oath of allegiance, in the presence of at least three witnesses capable of confirming his participation in this event.
- that the nominated candidate actually made a speech and took an oath in front of at least three witnesses capable of confirming his participation in this event.

- that the nominated candidate has actually applied his hand (Fingerprint) and signed the Magna Carta as a sign of acceptance of his duties and responsibilities of the office.

To ensure the peaceful administration of my estate and respect for its boundaries and property, the General Executor and Guardian is also authorized to appoint the government of my estate to the Office of the Prime Minister and to appoint other trustees or agents under oath.

The General Executor and Guardian shall at all times retain the right and authority to make, approve, disapprove and revoke all edicts, statutes, regulations, commissions, warrants and powers issued under the Great Seal by the departments of the estate, and to revoke and revoke any commission or warrant of any officer or agent found to be in gross violation of their duties and obligations under the laws of our estate.

Article Seventeen (17) – Funeral rites and memory.

The executor general and guardian shall have sole responsibility as overseer of the preparation, administration and supervision of the funeral rites and memorial rites as expressed herein.

The executor-general and guardian are requested to provide a suitable burial site for the remains as well as a simple Memorial upon the physical death of the testator's body.

The memorial and burial plot must be of a suitable form and style befitting the life of the testator, and the dedication and obituary language chosen by the executor-general and guardian must be respectful and appropriate.

After the physical death of the testator, the executor-general and guardian shall ensure that the ashes of the body rest in the sanctuary for three days and two nights without any disturbance and that no act will be allowed to desecrate the integrity and sanctity of the sanctuary.

The executor-general and guardian shall provide a private funeral service. to bless the remains before they are scattered and if sufficient interest is shown, see that opportunity is given to those who wish to pay their last respects.

Any expenses associated with funeral arrangements are deductible from the estate accounts of the executor-general and guardian.

Article Eighteen (18) – Fiduciaries (Trustees).

The Chief Executor and Guardian has the power and authority to appoint, direct and terminate the commissions working under the Minister General, as the sole director and first minister of government for our estate and, on the advice of the Minister General, to appoint one or more trustees to assist, in as government, and for the administration of our supreme estate, in accordance with the oath of allegiance and oath of office.

No bonds or other securities shall be required in any jurisdiction of any executor or trustee under this Covenant named or appointed pursuant to this Covenant, unless otherwise required by law, in which case such bonds or securities shall be provided with our property.

Each successor executor and successor fiduciary shall have all the rights and discretionary powers granted to the predecessor executor and fiduciary, except those rights and discretionary powers that may be prohibited herein.

To ensure the proper administration of our estate, and subject to any limitations set forth elsewhere in this Sacred Document, the executors and fiduciaries have the following powers in

addition to any other powers granted by law.

- to the extent not prohibited by law, the right to retain physical possession of any tangible or intangible property in our estate or in any trust under our jurisdiction.
- continue to hold any property, including shares of the trust, or act at the risk of our estate and not at the risk of the Fiduciaries , any property or business received in this trust, for so long as the Fiduciaries consider it appropriate, profits and losses from it will accrue or be taxed on our estate rather than the Fiduciaries .
- management, control, sale, transfer, exchange, division, improvement, repair. grant of options and deferred sales, leases on terms within or after the expiration of the trust for any purpose, to compromise, arbitrate or otherwise adjust claims for or against the trust, to create restrictions, easements and other services, to secure such insurance as the fiduciary authorities may deem appropriate.
- invest and reinvest fixed capital and income, if accumulated, as well as acquire or acquire with its help any property, real, personal or mixed, and carry out all types of investments, including, but not limited to, corporate obligations of any kind and shares, preferred or common, to invest in any general purpose fund.
- borrow money for any trust purposes on such terms as the fiduciary may deem proper and obligate my estate to repay it, encumber our estate or any property thereof with a mortgage, deed of trust, pledge or otherwise, using such procedure to complete the transaction as the fiduciary may deem appropriate.

No fiduciary shall have any liability for any acts or omissions unless such fiduciary acted in bad faith or exercised reasonable care, diligence and diligence. In no event shall any fiduciary be liable for the failure of any other fiduciary, except to the extent that such fiduciary may be held liable for his own wrongful acts.

The fiduciary must keep, or cause to be kept, proper records of all receipts and payments to our estate and all transactions related to my estate. As soon as practicable after the end of each accounting period, the fiduciary must prepare, or cause to be prepared, a financial statement showing the financial position of our estate as of the end of that accounting period.

All decisions with third parties relating to the duly appointed trustee are fully binding as if they had been executed or performed by the Principal Executor and the Guardian. All authorizations are valid until those relying on them receive actual notice of their revocation.

No individual executor or fiduciary is entitled to receive statutory commissions for serving in such capacity.

The Executive and Guardian General, on the recommendation of the Minister General, in the person of the Principal and the Head of Government, may appoint and nominate, by letters patent under the Great Seal, as official correspondent, any competent person transferred to the Office and under oath of a foreign state, entity or corporation as a fiduciary subject, provided that:

- the person in question is bound to hold such office under oath or oath and that such terms are recognized by the laws of the foreign power.
- the person in question is the most senior official of a particular foreign state, political body, legal entity or corporation, responsible as Principal for one or more subordinate persons.
- there is written evidence that one or more persons under the authority of the relevant senior person have acted and continue to act in a “fiduciary capacity” with respect to the rights of our superior estate.
- there is written evidence that one or more persons under the authority of the relevant senior officer have acted and continue to maintain a “fiduciary relationship” with certain persons and

rights of our superior estate.

-that no application has been made to any other person within a particular foreign state, political body, legal entity or corporation to appoint him or her as a fiduciary.

Since there is a requirement for written evidence of both fiduciary capacity and fiduciary relationship with persons under the authority of any fiduciary nominee appointed by patent sealed by the General Executor and Guardian, a person of a foreign legal entity who has entered into office under the oath of a foreign state who refuses from formalizing his involvement in the affairs of our estate as an appointed executor-general and guardian fiduciary, is guilty not only of bad faith and dishonesty , but also of gross dishonesty and denial of the Rule of Law, due process and justice. If the immediate superior, duly notified, fails to reprimand the perpetrator for such actions, then such failure to act must be ecclesiastical , legal and legal construed as a public notice and official record that the rule of law and justice in that foreign country has ceased to exist. existence.

One or more trustees may provide services to my estate or any Trust under this Testament, as an officer, manager or employee of our estate or any Trust or in any other capacity, notwithstanding the fact that they may be appointed by a superior authority to perform such functions and they are entitled to receive reasonable compensation for such services. None of these men or women should bind themselves to the estate when performing services.

If any executor or fiduciary is determined to be disabled by two physicians, this determination of disability also means that person's immediate resignation as executor or fiduciary without any further action.

Article nineteen (19) – Agents.

-The Minister General, as the leader and head of the government, has the right and authority to appoint, direct and terminate the work of commissions under the oath of allegiance and oath of office consisting of one or more authorized agents (hereinafter “agents”) to assist in the execution of the administrative orders of our estate.

-No bonds or other guarantees shall be required in any jurisdiction of any agent nominated or appointed pursuant to this Covenant, unless otherwise provided by law, in which case such bonds or guarantees shall be secured by my estate.

-The Secretary General is directed to appoint, as soon as possible, an agent as Recorder for the proper maintenance, as the Public Record, of all titles, notices, dispositions and documents of our property.

-The Minister General is directed to appoint an agent as clerk to properly catalog, convey and compile documents relating to the administration of my estate. The same person appointed as Registrar may also be appointed as Clerk.

-The Minister General has been instructed to appoint a receiver as bailiff to ensure the collection and safety of all the property of our estate. It is preferable for such person to already have sufficient training, skill and recognition from other parties to effectively perform their duties.

-Any competent person of a foreign state, organization or corporation represented as an agent acting in a fiduciary capacity or in a fiduciary relationship with one or more persons and rights of our superior estate shall automatically become such agent in accordance with the provisions of this Sacred Instrument.

-If there is clear written evidence of fiduciary capacity or fiduciary connection between my superior estate and a foreign agent, and that agent then refuses to obey the direction of the Secretary General, then such agent is guilty not only of bad faith, but also of gross dishonor. If a foreign state, entity, or corporation then fails to reprimand and correct such violation, then such failure to act must be ecclesiastically , legally, and legally construed as a public notice and official record that the rule of law and justice in that foreign state has ceased to exist. .

## Article twentieth (20) – Beneficiaries.

The General Executor and Guardian has the power and authority to assign, grant, grant, administer, revise or terminate Commissions to one or more beneficiaries from any present or future income from our estate or any Trust of our estate, consistent with these degrees and the intentions and desires expressed in this Holy Document.

A party not named as a beneficiary is excluded by the express intent of both the Grantor and the Testator.

The Principal cannot refuse to pay Commissions to a named beneficiary unless the beneficiary waives its rights or fulfills any specific obligation.

The Beneficiary has the right to refuse to receive Commissions prior to their acquisition, possession or use. However, a beneficiary who has already acquired, possessed or enjoyed certain rights and properties defined in this sacred instrument shall be deprived of any right to renounce the benefits and obligations contained herein.

Any foreign power which has established by its charters, decrees and directives certain obligations and benefits arising from the rights and properties proclaimed by this sacred instrument and continues to hold, possess or use one or more of these rights or properties, in accordance with required by law to act as a beneficiary until proper notice is given.

If there is clear written evidence of the trust of certain rights and properties enumerated by this sacred document between my superior estate and a foreign government, organization or corporation, and that body then refuses to perform the obligations required of such beneficiary, then such body is guilty of not only bad faith, but also in denial of their own laws. If the most senior fiduciary of such foreign state, entity or corporation then fails to reprimand the offender and correct such violation, then such failure to act shall be ecclesiastical, legal and legal construed as a public notice and official record that the rule of law and justice in this foreign country, legal entity or corporation has ceased to exist.

## Article twenty-one (21) – Wards.

The General Executor and Guardian has the right and authority to represent and protect the interests of all wards and persons of our estate, including all obligations for their proper care, as well as the proper management of their affairs.

Since a legal entity, by definition of the law, is an "infant born of statute", the executor-general and guardian has primary and primary custody of all legal entities bearing the name Alena Sergeevna Vorobyova and all variations thereof, regardless of whether such persons were born under the laws our estate or any foreign country.

In cases where a person bearing the name Alena Sergeevna Vorobyova or any variation of it is subject to the laws of a foreign country, the executor general and guardian are required to ensure that the claim is brought as soon as possible and notification of the existence of higher jurisdiction.

If a person bearing the name Alena Sergeevna Vorobyova or any other change thereof is subject to the laws of a foreign country and seeks refuge and protection from our estate, then before the executor general and guardian ensure that the issue of international jurisdiction is resolved, that person may file a petition and require that the question of jurisdiction be heard by the highest court of our estate, and then issue a writ of writ to the foreign country to surrender all relevant matters to the government of our estate.

Since a legal entity, by definition of the law, is an "infant born of the statute", the executor general and guardian has first and foremost custody of all legal entities born in the name of Svetlana Nikolaevna Vorobyova and all its variations, regardless of whether such persons were born from the laws of our estate or of any foreign country.

In cases where a person bearing the name Svetlana Nikolaevna Vorobyova or any variation thereof is subject to the laws of a foreign country, the executor general and guardian are required to ensure that the claim is brought as soon as possible and notice of the existence of higher jurisdiction.

If a person bearing the name Svetlana Nikolaevna Vorobyova or any other change thereof is subject to the laws of a foreign country and seeks refuge and protection from our estate, then before the executor general and guardian ensure that the issue of international jurisdiction is resolved, that person may file a petition and require that the question of jurisdiction be heard by the highest court of our estate, and then issue a writ of writ to the foreign country to surrender all relevant matters to the government of our estate.

Since a legal entity, by definition of the law, is an "infant born of the statute", the general executor and guardian has first and foremost custody of all legal entities named Pavel Sergeevich Vorobyov and all its variations, regardless of whether such persons were born under the laws of our estate or any foreign state.

In cases where a person bearing the name Pavel Sergeevich Vorobyov or any variation of it is subject to the laws of a foreign country, the executor general and guardian are required to ensure that the claim is brought as soon as possible and notice of the existence of higher jurisdiction.

If a person bearing the name Pavel Sergeevich Vorobyov or any other change thereof is subject to the laws of a foreign country and seeks refuge and protection from our estate, then before the executor general and the guardian ensure that the issue of international jurisdiction is resolved, that person may file a petition and require that the question of jurisdiction be heard by the highest court of our estate, and then issue a writ of writ to the foreign country to surrender all relevant matters to the government of our estate.

Article Twenty Two (22) – Public Record and Public Notice.

The public records of my estate are primarily the estate rolls and all excerpts from those official documents.

Public notice of my estate must be in the form of both certified evidence and published in one or more of the official Gazettes of the respective Communities.

Article Twenty-Three (23) – Jurisdiction and Laws of Foreign States.

The Executive and Guardian General, the Minister General and all duly appointed fiduciaries and agents hereby acknowledge the laws of those foreign powers where the rule of law, due process and justice are observed, without prejudice to the provisions of this Covenant.

All officers, employees, fiduciaries and agents duly appointed under this sacred document shall conduct themselves and act in such a manner as to avoid unnecessary controversy, observe the general rules and decency of a civilized society and in particular those rules and regulations that relate to the use of roads and transport, respect for public property and premises, privacy, safety and respect for other men, women or persons and positive contributions to society as a whole. The

fiduciaries, agents and beneficiaries of a foreign power may have jurisdiction over our superior estate only to the extent prescribed by this sacred instrument.

Article twenty-four (24) – Agreements with Foreign States.

All official communications from our estate to internationally recognized foreign countries must first be recorded in our estate's Rolls.

In the event that the relevant large community registry is not operational or community officials have not been elected, the executor-general and guardian must record the official message in the Great Rolls of our estate, then it must be properly executed and apostilled independently, and then sent directly to its intended destination.

Official international recognition of our estate and any official relations with internationally recognized foreign countries must be established through appropriate treaties. With primary recognition that was first established by communities.

In the event that the relevant large community registry is not operational or Community officers are not elected, the executor-general and guardian must seek direct official international recognition of our estate by other foreign countries. In addition, the executive general must seek to conclude an international treaty of peace, goodwill and commerce with the same foreign countries.

Article twenty-five (25) – Property owned by Foreign states.

The Executor General and Guardian has the rights and powers as herein defined to grant by warrant and letters patent to beneficiaries, trustees or agents one or more of those rights vested in our estate, whether or not the property in question is directly held. our estate subject to these Articles.

If certain property or rights belonging to my estate are owned, possessed or declared to belong to a foreign country, the executor general and guardian must ensure that the claim is properly entered into the Rolls of our estate and that notice of the claim, including a copy of the claim the claims were made against officials of a foreign country claiming false ownership or illegally possessing a right or property. If such a claim is ignored, it is the responsibility of the

Executor General and Guardian to seek any form of legal remedy, including the assistance of my allies.

Article twenty-six (26) – Financial instruments, Drafts and Securities.

The Minister General, as the Chief Executive Officer of the Government, has the power and authority to approve such financial instruments as negotiable instruments and Drafts associated with one or more valid Funds established for the effective administration of our supreme estate, including the due protection and security of such instruments, subject to the provisions set out in these Articles and any foreign treaties concluded by the Minister General which establish limitations and conditions for the operation of such instruments in exchange for their international recognition.

Article twenty-seven (27) – Compensation and payment schedule.

The General Executor and Trustee is directed to develop and publish a schedule of fees and compensation for official business transactions conducted for and on behalf of our estate that reflects accepted professional and fair rates of expense and compensation.

In any official business conducted for and on behalf of our estate, the executor general and the guardian or trustee shall publish a schedule of fees and compensation so that no business is conducted by duly appointed officers or third parties without taking into account expenses and accounting for compensation.

If anyone acting as trustee or executor, or any person acting as agent for the administration of the property of our estate, refuses to acknowledge the authority of the executor-general and guardian or one of their duly authorized representatives, they therefore personally accept assume responsibility for any fees and compensation and damage caused to our property in general.

Article twenty-seven (27) – Maria Sparrow's Trust .

Upon the lawful assumption of the office of the Minister General as the head and leader of the government of our supreme estate, upon the entry into force of this Sacred document and the public notice of its existence, the executor general and the guardian are directed to immediately promulgate and put into effect a valid charter and constitution for the formation of the trust company Maria Sparrow for the non-profit and charitable church management of all funds of all funds and accounts, all real estate and property rights and management of all sacred benefits provided to our relatives, our community by birth and our brotherhood and union.

Once the property is registered in the Great Estate Rolls, the Minister General and the Government are hereby authorized to register the Mary Sparrow Trust Company as a foreign non-profit and charitable church organization for the purpose of enabling it to discharge all debts and obligations to foreign estates, corporations, individuals, associations, states and organizations, as well as accept any loans, gifts or donations from them. As a sign of respect and respect for the foreign laws, protocols and conventions of foreign powers with which the Maria Sparrow

Trust Company may be registered, the Minister General and the Government are hereby authorized to ensure that the company's job titles identify it as a non-profit and charitable church organization and not as a company of another the nature, activities and designation of which would otherwise be publicly contested by the officials and agents of such foreign powers. I, direct that all necessary expenses for registration, taxes, education, utilities, rent, fees, licensing be financed in such a way that my spouse and immediate family can be

provided with the comforts and support of home to meet all necessary needs. After due search and accounting of all our property, I order the Chief Executor and Guardian to provide an equal amount of money to each of the following closest relatives and true friends: If my (son) survives me, a living man Sergei Nikolaevich from the Vorobiev family, If my (daughter) survives me, a living woman Svetlana Nikolaevna from the Vorobyov family, If my (granddaughter) survives me, a living woman Alena Sergeevna from the Vorobyov family, If my (grandson) survives me, a living man Pavel Sergeevich from the Vorobyov family,

#### Article twenty-nine (29) – Peaceful resolution of disputes.

If there is a dispute between any parties regarding any of the rights listed here, then the amicable resolution of such dispute must be brought before a competent legal authority. Since the dispute can only be settled before a competent legal authority, the following rights of this Sacred Document must be recognized:

1. The absolute right to try cases in a competent court, inherited from ( Ius Oratorium ) and ( Ius Naturale Aequum ).
2. Absolute Right to Equality, inherited from ( Ius Aequum ), and ( Ius Naturale Aequurrv )
3. Absolute Right to Information, inherited from ( Ius Leges Sciri ), and ( Ius Naturale Indicium ).
4. The absolute universal Right to accuse another of a crime, inherited from ( Ius Accusare ), and ( Ius Naturale Verum ).
5. The absolute Natural Right of defense against any accusation and accuser, inherited from ( Ius Defensionis ), and ( Ius Naturale Honestas ).
6. The absolute Natural Right to know the accuser and the accusations, inherited from ( Ius Accusationis Sciri ), and ( Ius Naturale Indicium ).
7. The absolute Natural Right to summon all parties to a competent court for the determination of a dispute, inherited from ( Ius Vocatio ), and ( Ius Naturale Indicium ).
8. The absolute Natural Right to arrest a suspect by warrant or cause of law for the purpose of serving an indictment and summons, inherited from ( Ius Prendi ), and ( Ius Naturale Indicium ).
9. The absolute universal Right of innocence until the charge is proven, inherited from ( Ius Innocentiae ), and ( Ius Naturale Aequum ).
10. The absolute right to adequate time to prepare a defense, inherited from ( Ius Defensionis Tempus ), and ( Ius Naturale Aequum ).
11. The absolute Right to defend oneself or to accuse anyone, inherited from ( Ius Sui Iuris ), and ( Ius Naturale Aequum ).
12. The absolute Right to appoint an agent for the defense or prosecution, inherited from ( Ius Agens ), and ( Ius Naturale Aequum ).
13. The Absolute Right of Jury, inherited from the Natural Right of Jury, also known as ( Ius Iudicium ), and ( Ius Naturale Aequum ).
14. The absolute right to decide a matter by a competent court, inherited from ( Ius Tribunal ), and ( Ius Naturale Aequum ).
15. The absolute right to decide a matter in good faith (under oath), inherited from ( Ius Bonum Fidei ), and ( Ius Naturale Verum ).
16. Absolute Right to decide a matter without Prejudice, inherited from ( Ius Sine

Praejudicium ), and ( Ius Naturale Honestas ).

17. Absolute Right to resolve the issue “with clean hands” i.e. in good faith, inherited from ( Ius Mundis Manibus ), and ( Ius Naturale Honestas ).

18. The absolute right to challenge detention without proof of legal grounds, inherited from ( Ius Habeas Corpus ), and ( Ius Naturale Honestas ).

19. Absolute Right to require an employee to perform the duties assigned to him, inherited from ( Ius Mandamus ), and ( Ius Naturale Honestas ).

20. Absolute Natural Right to demand proof of the legality and legitimacy of the current government, inherited from ( Ius Quo Warranto ), and ( Ius Naturale Honestas ).

21. The Absolute Right to Change Venue is inherited from the Natural Right to Change Venue, also known as ( Ius Certiorari ) and ( Ius Naturale Aequum ).

22. The absolute right to demand the termination of legal actions before a decision is made by the competent authority, inherited from ( Ius Prohibitio ), and ( Ius Naturale Aequum ).

23. The absolute right to claim an action subject to due process of law, inherited from ( Ius Procedendo ), and ( Ius Naturale Aequum ).

24. Absolute Right to demand the correction of identified errors in records inherited from ( Ius Error Coram Nobis ), and ( Ius Naturale Aequum ).

25. The absolute Right to demand that false claims be withdrawn or directed to the proper person, inherited from the Natural Right to demand that false claims be withdrawn or directed to the proper person, also known as ( Ius Scire Facias ) and ( Ius Naturale Aequum ).

If the declared forum does not recognize one or more of these fundamental rights, then it immediately disqualifies itself as a competent judicial authority and therefore cannot be the forum for resolving any dispute.

I hereby reject the jurisdictional power and authority of any body or court acting under the laws of the Admiralty or Summary Jurisdiction, which demonstrates the absurdity and violation of law that a person can be found guilty before the matter has even been tried. competent court, contrary to my Absolute universal right of innocence until the charge is proven, inherited from ( Ius Innocentiae ).

If the case is brought before a competent court or authority acting under the laws of the Admiralty or Summary Jurisdiction, or one which overrides my fundamental rights as prescribed herein, then any presence at the trial of a Fiduciary, Agent or other person engaged for the settlement and resolution of this matter shall be an official visit only and no imputation, assumption, contract or agreement of jurisdiction shall have any legal effect.

Article thirty (30) – Nomination of a candidate for the position of General Executive.

We hereby declare, anoint, confirm and appoint the competent person known as Sergei Vorobyov to be the executor and guardian of our entire estate.

If Maria Mikhailovna Vorobyova (maiden name Dorozhkina ) is unable or unwilling to fulfill the duties of general executor and guardian, or she decides to abdicate the throne, we hereby announce, anoint and confirm that Svetlana Nikolaevna Vorobyova is third in line of succession.

If Svetlana Nikolaevna Vorobyova is unable or unwilling to fulfill the duties of general executor and guardian, or she decides to abdicate the throne, we hereby announce, anoint and confirm that Pavel Sergeevich Vorobyov is the fourth contender in the line of succession.

If Pavel Sergeevich Vorobyov is unable or unwilling to fulfill the duties of general executor and guardian, or he decides to abdicate the throne, we hereby declare, anoint and affirm that Alena Sergeevna Vorobyova is fifth in line of succession.

If Alena Sergeevna Vorobyova is unable or unwilling to serve as Executive and Guardian General, or if she decides to abdicate the throne, we hereby announce that all subsequent candidates will be selected by open vote from among the existing Trustees and Administrators sworn in as part of the Executive government of our estate.

Upon the lawful assumption of office of the Minister General, (Prime Minister and Government), subsequent to the commencement of this Sacred Document and the public notice of its existence being publicly registered, the Executor General and the Guardian are directed to immediately issue a valid Charter and Constitution for the grant and formation of the Trust Sergei Vorobyov's company for the non-profit and charitable church management of all funds of all funds and accounts, all real estate and estate rights and management of all sacred benefits provided to our family and friends, Our union community, our birth community and our brotherhood.

Article thirty-three (33) – Testament (Probate of will) and proof of last will.

I, hereby, declare, enjoin, publish and approve the following Perfect Proof ( Probatio Perfecta ) as a formalized solemn perfect evidentiary process, conditions and criteria by which the validity of this Sacred Document, which from the point of view of its legal personality as a will, shall be duly tested, checked, examined and confirmed by the General Executive in his usual capacity.

Only the formal conditions and criteria of solemn process set forth herein as part of the perfect evidence may be used to properly examine, examine and prove this Sacred Instrument for its legal personality as a will and a will only, without implication of any other laws, rules, canons , decrees, resolutions or orders.

The Chief Executive, in his ordinary capacity, has exclusive territorial jurisdiction, personal jurisdiction and subject matter jurisdiction over perfect evidence and is not subject to any other court, forum of law, tribunal or authority.

If proceedings are commenced in any other court, forum of law, tribunal or authority in a matter determined to fall under the law of intestacy and not under the control of the executor-general as per the ideal of proof, then such authority shall immediately terminate the same until such time as until such proceedings come under the exclusive jurisdiction of the General Executor.
