Jus Flavianum (Flavian Law) - implied laws and rights of ancient times, formulated by Gnaeus Flavius;

Jus Gladii (The Right of the Sword) is the right of the sword and the executive power of the law, and Jus Futurum (Future Law) is the proclaimed future law that has not yet entered into force.;

Jus Necis (The Right to Death penalty) - the declared legal right to impose the death penalty;
